## Texas Christian Educational Foundation Inc. Waiver & Release from Liability

I \_\_\_\_\_ hereby WAVE AND RELEASE indemnify, hold harmless and forever discharge TEXAS CHRISTIAN EDUCATIONAL FOUNDATION, INC., its agents, employees, officers, directors, affiliates, successors, coaches, and teachers of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damages and liabilities, of ever kind and nature, whether known or unknown, in law or equity, that I ever had or may have, arising from or in any way related to my participation in any of the events or activities conducted by, on the premises of, or for the benefit of TEXAS CHRISTIAN EDUCATIONAL FOUNDATION, INC. provided that this waiver of liability does not apply to any act of gross negligence, or intentional, willful or malicious misconduct.

I understand that the facilities, premises or area used, in which I will participate or use, may be considered inherently dangerous and may cause serious or grievous injuries, including bodily injury, damage to personal property and/or death. On behalf of myself, my heirs, assigns, administrators, executors and next of kin I waive all claims of bodily injuries or death to me or damage to any of my personal property, including all claims in tort, contract, equity or otherwise,

By this waiver, I assume any and all risk and take full responsibility and waive any claims for personal injury, death or property damage associated with the Texas Christian premises, including but not limited to using the facility and its equipment in any manner, form or fashion, and participating or engaging in any activities either on or off of the Texas Christian premises.

This WAIVER AND RELEASE represents the entire agreement between the parties, and supersedes any prior written or oral agreements between the parties. The provisions of this WAIVER AND RELEASE may be waived, altered, amended or repealed, in whole or in part, only upon the written consent of all parties. All provisions of this WAIVER AND RELEASE shall remain in full force and effect even after the termination of services or this agreement.

I have read and I am in agreement with the WAIVER AND RELEASE. I understand and confirm that by signing this WAIVER AND RELEASE that I have given up considerable future legal rights. I have signed this agreement voluntarily, under no coercion or threat of coercion, without inducement, promise or guarantee being communicated to me. My signature is proof of my intention to execute a complete and unconditional WAIVER AND RELEASE of all liability to the full extent of the law. I am 18 years of age or older and mentally competent to enter into this waiver.
